USE

Storage/Shelf Life	Store for up to 12 months from date of manufacture in original, unopened packaging under cool, dry, conditions within the temperature range of +5°C to +30°C and out of direct sunlight. Protect from frost. Store in a well ventilated area.

DIRECTIONS FOR USE

Depending on the degree of residue, **SANTRAX BRICK**, **TILE and CONCRETE CLEANER** can be applied neat or diluted up to 1 part concentrate to 4 parts water. Spray product on surface or apply product with a brush. The product may bubble on surface, this is normal. The product can be worked into the surface with a brush. Allow to react with the surface (can take up to 1 hour depending on surface). Rinse surface thoroughly with plenty of water.

<u>Warning</u>: Test **SANTRAX BRICK**, **TILE** and **CONCRETE CLEANER** on a small section of the surface to be treated. Allow the area to dry before assessing the result.

Do NOT apply **SANTRAX BRICK, TILE and CONCRETE CLEANER** to calciferous stone such as marble or granite. Do NOT allow product to come into contact with metal surfaces, for example, metal basins, draining boards, bathroom fittings or mirrors. Sufficient ventilation must be provided to prevent acid fumes attacking metal surfaces. Some discolouration may occur if the product comes into contact with some types of plastic or enamelled surfaces. Do not mix with other materials.

PRECAUTIONS IN USE

SANTRAX BRICK, TILE AND CONCRETE CLEANER Causes skin irritation. Causes serious eye irritation. May cause respiratory irritation. Keep out of reach of children. Do not breathe dust/fumes/gas/mist/vapours/spray. Wear protective gloves/protective clothing/eye protection/face protection. IF IN EYES: Rinse cautiously with water for several minutes.
